BOOTH ALLOCATION ACT

The Booth Allocation Act will take place on **Wednesday 3rd of July, 2024 at 2 pm** at the **ATVC** headquarters, **Av. Paseo Colón 525, 10th Floor, C.A.B.A.**

Companies which have fully paid their booths up to **Tuesday July 2nd at 5 pm** will be able to participate.

Together with their payment, the companies must present the Booth Purchase Form or send by e-mail the **BOOTH PURCHASE FORM** contained in this folder.

Starting **Thursday July 4th**, companies may choose their spaces upon presenting at ATVC offices the Booth Purchase Form and paying the full value of the chosen booth. If payment was made by a bank transfer, a copy of the bank receipt must be presented by mail to **claudia@atvc.org.ar** together with the **Booth Purchase Form**.

The day of the Booth Allocation Act the booth locations will be granted in the presence of a Public Notary by means of a draw machine, in the following order: central 18 sq. mts; peripheral 18 sq. mts; central 9 sq. mts and peripheral 9 sq.mts.

The participating companies will be grouped by categories according to the above-mentioned booth sizes. When arriving to the Booth Allocation Act, the company representative will receive a color ticket with a number. Each booth category will have a different color ticket.

Once the Booth Allocation Act starts and always following the order of size and location of the purchased booths, the Public Notary will proceed to draw out numbers, category by category, until all companies included in each category have chosen their locations in the exhibition floor.
